Dear Chairman England:

We, the undersigned organizations, are a coalition of concerned Georgians working to improve outcomes in maternal health. We request that provisions be made in the FY 2021 budget to extend postpartum Medicaid coverage of mothers in our state up to one year. Implementation of this policy would be one of many necessary steps to addressing the maternal mortality and morbidity crisis in Georgia.

Data show that Georgia has the worst maternal mortality ratio of any state in the country. Black women in Georgia are 3.3 times more likely to die from pregnancy-related complications than white women are, and Georgia's own health experts believe that more than half of confirmed pregnancy-related deaths in the state are preventable. Based on the latest report from Georgia's state mandated Maternal Mortality Review Committee, 82% of maternal deaths occurred in the postpartum period, up to one year. Yet, women enrolled in Medicaid for pregnancy lose coverage only 60 days after delivery.

Children born to women who are covered by Medicaid during pregnancy are automatically eligible for Medicaid or Child Health Insurance Program (CHIP) for one year. Unfortunately, this same length of coverage is not extended to the mothers of these children. Extending Medicaid coverage of moms to one year after they deliver will ensure that they have access to critical health care services and demonstrate that Georgia values women's health. This recommendation has been made by both the state's Maternal Mortality Review Committee⁵ as well as the General Assembly's own recently convened Special Study Committee on Maternal Mortality, chaired by Representative Sharon Cooper.

We acknowledge the great strides in improving maternal health made by the General Assembly over the past two years, and we urge lawmakers to continue proposing and passing legislation
